MINUTES OF THE MEETING **APRIL 9, 2002**

Mr. Denning informed the Board that Green Valley Builders has paid SNE Equipment Services in full.

MR. JOHNSON MOVED TO DISMISS ALL CHARGES.

MR. CARSON SECONDED THE MOTION.

Judge Arthur Gladstone presented administrative law training to the Board Members and Board staff.

4. DISCIPLINARY HEARINGS:

1. CAMCO PACIFIC CONSTRUCTION COMPANY, INC., LICENSE #37507

This matter was continued to the next Henderson Board meeting on April 23, 2002.

2. HANKS CONSTRUCTION, LICENSE #44456

Mr. Alvin R. Hanks, Owner Hanks Construction; Christine Hanks, Hanks Construction; Captain Kole London, Homeowner; and Investigator Gary Leonard were sworn in.

The hearing was for possible violations of NRS 624.3017 (1); and NRS 624.3013 (5).

The Notice of Hearing and Complaint was entered into the record as Exhibit #1.

Mr. Hanks testified there are access issues with the homeowner Captain London.

Captain London testified he entered into a contract on May 8, 2001 with the Respondent to build a home. He filed a complaint for shingle molding painting and siding replacement. He has not allowed the Respondent on his property to fix or replace the workmanship issues.

Mr. Leonard testified he validated the workmanship complaint and issued a Notice to Correct. Approximately 5% of the siding needed to be replaced due to a manufacturer defect and the shingle molding needed painting. Captain London would not allow the Respondent or the subcontractor painter on his property to complete the work.

Mr. Hanks testified he attempted to schedule with the homeowner on numerous occasions to fix the items on the Notice to Correct, however Captain London would not allow him on the property. Mr. Hanks stated he received phone calls from other contractors indicating that Captain London was requesting bids to replace the siding and/or to apply stucco. Captain London had removed the siding on the home and had contacted the siding manufacturer himself and received a refund for the siding.

Mr. Leonard testified Mr. Hanks notified him that Captain London may have contracted with another contractor to replace the siding or to apply stucco on the home.

Captain London testified he received a full refund from the siding manufacturer. He stated he did not deny the Respondent or any painter access to his property, however, he hired another contractor to paint and install new siding.

Mr. Leonard testified the siding was installed correctly by the Respondent.

The evidentiary portion of the hearing was closed.

MS. CAVIN MOVED TO DISMISS ALL CHARGES.

MR. JOHNSON SECONDED THE MOTION.

THE MOTION CARRIED.

3. RECHEL AND SONS CONSTRUCTION COMPANY, LICENSE #46705

Mr. Jeffrey M. Rechel, Owner Rechel and Sons Construction Company; Robert Watson, Homeowner; and Investigator Gary Hoid were sworn in.

The hearing was for possible violations of NRS 624.3017 (1); NRS 624.3013 (5); and NRS 624.3015 (2).

The Notice of Hearing and Complaint was entered into the record as Exhibit #1.

Mr. Watson testified he entered into an agreement with Larry and Sue Gardner to purchase a home that was under construction on June 12, 2001. After the home was completed he noticed the bathtub was cracked and the kitchen cabinets were warped. The Respondent would not fix the problems and he filed a complaint.

Mr. Hoid testified he validated the workmanship complaint and issued a Notice to Correct with two workmanship items.

Mr. Rechel testified he has had problems scheduling the subcontractors to repair and/or replace the items on the notice to correct.

MR. CARSON MOVED TO CONTINUE THE HEARING TO THE NEXT RENO BOARD MEETING ON MAY 7, 2002.

MR. JOHNSON SECONDED THE MOTION.

THE MOTION CARRIED.

3. TIRADE CONSTRUCTION COMPANY, LICENSE #42502

This matter was continued to the next Reno Board meeting on June 4, 2002.

4. GARY P. LACHASSE, LICENSE #36149

Mr. Anthony Grasso, Homeowner; and Investigator Gary Leonard were sworn in.

No one from Gary P. Lachasse was present.

The hearing was for possible violations of NRS 624.3015 (2); NRS 624.3013 (5), as set forth in NAC 624.640 (5); NRS 624.3013 (3); NRS 624.3013 (5), as set forth in NAC 624.600; and NRS 624.3013 (4).

The Notice of Hearing and Complaint was entered into the record as Exhibit #1.

Mr. Grasso testified he entered into a contract with the Respondent to build a home in May, 2000. The Respondent did not finish the house and hired another contractor to complete

the project.

Mr. Leonard testified he validated the complaint and issued a Notice to Correct.

The evidentiary portion of the hearing was closed.

MR. JOHNSON MOVED TO REFER TO FORMAL FINDINGS OF FACT, AND CONCLUSIONS OF LAW.

MR. CARSON SECONDED THE MOTION.

THE MOTION CARRIED.

MR. JOHNSON MOVED TO FIND GARY P. LACHASSE, LICENSE #36149 IN VIOLATION OF ALL CHARGES; TO REVOKE LICENSE #36149 GARY P. LACHASSE; TO REQUIRE FULL RESTITUTION TO THE DAMAGED PARTIES; AND TO RECOVER THE INVESTIGATIVE COSTS OF \$2,626.00 PRIOR TO CONSIDERATION OF FUTURE LICENSURE.

MR. CAVIN SECONDED THE MOTION.

THE MOTION CARRIED.

6. WALT LEE CONSTRUCTION COMPANY, INC., LICENSE #20058, 14273 AND 25445

Mr. Walter M. Lee, President Walt Lee Construction Company, Inc.; and Investigator Larry Thompson were sworn in.

Charles Scott Zumpft, attorney for Walt Lee Construction Company, Inc. was also present.

The hearing was for possible violations of NRS 624.3013 (3) and 624.260 to 624.265; NRS 624.302 (5); and NRS 624.3013 (3).

The Notice of Hearing and Complaint was entered into the record as Exhibit #1.

Mr. Lee testified he filed personal bankruptcy and closed his business. He did not file corporate bankruptcy.

Mr. Thompson testified that United Rentals is in the bankruptcy.

Mr. Zumpft stated the Respondent would like to surrender all three of his licenses.

The evidentiary portion of the hearing was closed.

MR. CARSON MOVED TO ACCEPT VOLUNTARY SURRENDER OF LICENSE #20058 WALT LEE CONSTRUCTION COMPANY, INC.; LICENSE #14273 WALT LEE CONSTRUCTION; AND LICENSE #25445 WALT LEE CONSTRUCTION COMPANY, INC.

MR. JOHNSON SECONDED THE MOTION.

THE MOTION CARRIED.

5. APPLICATION HEARINGS:

1. POWELL CONSTRUCTION, - (B-2 RESIDENTIAL & SMALL COMMERCIAL)

Mr. Gregory D. Powell, Owner; Gregory Corn, attorney for Powell Construction; Karl Young, Owner Summit 76 LLC.; Jim Zernicke, Owner Z Framers; John Fericks, President Reno Construction, Inc.; and Licensing Analyst Ms. Diana Wallace were present.

The hearing was for possible violation of NRS 624.260; and NRS 624.263.

Ms. Wallace stated the applicant filed Chapter 7 Bankruptcy in April, 1999 was discharged. The Applicant did not disclose he had been licensed by the California State Contractors' License Board, and that the license was revoked. A copy of the record has been requested.

Mr. Powell stated he was not aware his California license was revoked. He moved from California over 10 years ago and thought his license expired.

MS. CAVIN MOVED TO CONTINUE THIS MATTER TO THE FIRST AVAILABLE RENO BOARD MEETING AFTER RECEIPT OF THE RECORD FROM THE CALIFORNIA STATE LICENSE BOARD.

MR. CARSON SECONDED THE MOTION.

THE MOTION CARRIED.

2. DESGENSPARK ELECTRIC, - (C-2A,G ELECTRICAL & RESIDENTIAL WIRING)

Mr. Tyson A. Degenhart, Owner Degenspark Electric; and Licensing Supervisor Ms. Kathy Stewart were present.

Ms. Stewart stated the financial statement submitted with the application was dated March 18, 2001 and did not demonstrate the availability of sufficient working capital. She has received a current financial statement dated March, 2002 on the indemnitors, Ludwig and Tamily Degenhart. Ms. Stewart stated the Applicant had several misdemeanor convictions in 1996 and 2000.

A discussion ensued regarding the type of projects the Applicant wished to perform and his prior convictions. Mr. Degenhart stated he will only bid one job and work one job at a time. He further stated his life is now under control.
