**2. FINANCIAL RESPONSIBILITY HEARING:**

**TODD DEE HUNTER dba, T & M LAWN MAINTENANCE & LANDSCAPE, LICENSE NO. 41565**

Licensee was present.

Hearing Officer Quinn granted the Respondent's request to lower its monetary license limit to \$5,000.00 and bond to remain at \$5,000.00. Respondent shall pay an administrative fine in the amount of \$150.00 each for the First and Second Causes of Action; investigative fees in the amount of \$472.16 and the Secretary of State is not brought to current status within sixty (60) days license number 75486 will automatically be revoked.
