FAITH VISION, INC., dba VISION BUILDERS, License No. 74754


Licensee was present and represented by Troy Domina, Esq. at the hearing.

ADJOURNMENT


There being no further business to come before the Board, the meeting was adjourned by ALJ Allison at 2:05 p.m.
