The Respondent shall pay an administrative fine of \$2,000.00 for First Cause of Action, \$50.00 for the Second Cause of Action for a total fine in the amount of \$2,050.00, reimburse the Board's investigative fees in the amount of \$2,024.00. Respondent was found not guilty of the Third Cause of Action.
