1. DISCIPLINARY HEARING:

Nestor Daniel Meza Owner, dba Desert Hills Landscape, License No. 72949

Licensee was present and was not represented by counsel.

ALJ Addison found the Respondent Nestor Daniel Meza, Owner, dba Desert Hills Landscape, license number 72949 guilty of one (1) violation of NRS 624.3017(1) substandard workmanship; one (1) violation of NRS 624.3015(1) acting beyond the scope of the license; one (1) violation of NRS 624.3013(5), pursuant to NAC 624.640(5) failure to include monetary license limit on contract; and one (1) violation of NRS 624.3013(5), pursuant to NRS 624.520(1) failure to provide the owner of the owner’s rights related to the Residential Recovery Fund. The Respondent shall pay a fine of \$500 for the First Cause of Action, Second Cause of Action is dismissed, \$250 for the Third Cause of Action, \$50 for the Fourth Cause of Action, \$50 for the Fifth Cause of Action and the Sixth Cause of Action is dismissed. Respondent shall reimburse the homeowner in the amount of \$13,025. Fine and reimbursement to the homeowner shall be paid within 30 days of the May 6, 2020 hearing or license number 72949 will automatically be suspended.

2. DISCIPLINARY HEARING: Continued from March 4, 2020

Komax Development Inc., License No. 67413

Licensee was present.

ALJ Addison found the Respondent Komax Development, Inc., license number 67413 guilty of one (1) violation of NRS 624.3011(1)(b)(4) failure to comply with the building laws of the state regarding industrial insurance and NRS 624.3013(3) failure to establish financial responsibility. License number 67413 is revoked. Respondent shall pay a fine of \$1,000 for the First Cause of Action, \$250 for the Second Cause of Action, and \$500 for the Third Cause of Action for a total fine in the amount of \$1,750, reimburse the Board’s investigative fees in the amount of \$2,350. Respondent is required to make full restitution to DIR and reimburse the Board for the fines and investigative costs prior to consideration of future licensure.


