### MINUTES OF THE WORKSHOP BEFORE THE NEVADA STATE CONTRACTORS BOARD JANUARY 6, 2022

**CALL TO ORDER:**

The workshop for LCB File No. R021-21 was called to order at 8:30 a.m. on Thursday, January 6, 2022 at a tele-meeting via Zoom. Exhibit 1 is the Notice of Intent to Act Upon a Regulation and a copy of the proposed regulation.

Mr. Geswein stated the notice of the workshop was posted in compliance with the open meeting law on the Board's Internet Website, the Public Notice Website, State Library and Archives, both offices of the Nevada State Contractors Board, and e-mailed electronically to persons who have expressed interest in being kept informed of the Board's meetings.

Mr. Geswein explained the purpose of the workshop is to receive comments from interested parties concerning the proposed regulation identified as LCB File R021-21. The proposed regulation is to amend NAC 624.590 to grant credit toward qualifications to applicants as mandated by the passage of AB 330 during the 2021 legislative session. The regulation also makes minor changes to NAC 624.640 related to display of license certificates and repeals NAC 624.678 in regards to duplicate licenses.

There were no online public participants to offer public comment and no written public comment was received.

Mr. Geswein stated that a hearing on the matter will be held January 13, 2022 at 8:30 a.m. The workshop was adjourned at 8:33 a.m.
