The Committee Members discussed the potential need for a new license category to address residential remodeling work.


It was moved and seconded to recommend that the board pursue a subclassification for residential remodeling and authorize the subcommittee to develop language for consideration. MOTION CARRIED.

Mr. Aaron West provided public comment concerning current handyman practices and was interested in further discussion concerning the residential remodeling classification.


The meeting was adjourned at 9:08 a.m.
