

STATE CONTRACTORS BOARD TAKES DISCIPLINARY ACTION AGAINST TWELVE CONTRACTORS

LAS VEGAS, NV – At its meeting on October 23, 2001, the Nevada State Contractors Board adjudicated cases against twelve licensed contractors.

Freedom Plumbing Inc., license number 44370A (Plumbing and Heating) based out of Las Vegas, NV was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; failure to pay for materials or services; and, failure to report a change of address or personnel to the board. The Board revoked the license of Freedom Plumbing Inc.

HCI Hinnewinkel Construction Inc., license number 44681 (Residential and Small Commercial) based out of Costa Mesa, CA was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to establish financial responsibility and failure to include license number and monetary limit on contract or proposal. The Board revoked the license of HCI Hinnewinkel Construction Inc.

High Bluff Construction Company, license number 37446 (Residential and Small Commercial) based out of Henderson, NV was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to cooperate in the investigation of a complaint; failure to establish financial responsibility and failure to include license number and monetary limit on a contract or proposal. The Board revoked the license of High Bluff Construction Company.

Allied Underground Inc., license numbers 28255 (General Engineering) and 28237 (Electrical) based out of Las Vegas, NV was found in violation of Nevada Revised Statute 624 for failure to pay for materials and services; failure to establish financial responsibility and failure to cooperate in the investigation of a complaint. The Board revoked the licenses of Allied Underground Inc.

Tri-Star Theme Builders Inc., license numbers 47219 (General Building) and 40861 (Theme Parks) and ***Raincross Development Corp.***, license number 35962 (General Building) based out of Las Vegas, NV were found in violation of Nevada Revised Statute 624 for failure to pay for materials and services; failure to cooperate in the investigation of a complaint; failure to establish financial responsibility; failure to keep in force a bond or cash deposit; failure to include license number and monetary limit on a contract or proposal; and, failure to report a change of address or personnel to the Board. The Board revoked the licenses of Tri-Star Theme Builders Inc., and Raincross Development Corp.

Euro Electric Service Inc., license number 50705 (Electrical) and ***Achim Bruno Koebke dba Euro Electric Service***, license number 45162 (Electrical), based out of Kahului, HI were found in violation of Nevada Revised Statute 624 for failure to pay for materials and services; failure to cooperate in the investigation of a complaint; failure to

establish financial responsibility; and, failure to keep in force a bond or cash deposit. The Board revoked the licenses of Euro Electric Service Inc. and Achim Bruno Koebke dba Euro Electric Service.

Howell Development Inc., license number 46879A (Excavating, Grading, Trenching and Surfacing; Sewers, Drains, and Pipes; Pipeline Conduits) based out of Henderson, NV was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to cooperate in the investigation of a complaint; failure to establish financial responsibility; and, failure to keep in force a bond or cash deposit. The Board revoked the license of Howell Development Inc.

Walchop Inc., license number 17738 (Concrete Contracting) and 17734 (Residential and Small Commercial) based out of Las Vegas, NV was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to cooperate in the investigation of a complaint; and, failure to establish financial responsibility. The Board revoked the license of Walchop Inc.

Terra Landscape & Concrete Construction, license number 49047 (Concrete Contracting) based out of Las Vegas, NV was found in violation of Nevada Revised Statute 624 for a fraudulent or deceitful act committed in the capacity of a contractor; failure to establish financial responsibility; failure to include license number and monetary limit on a contract or proposal; acting in the capacity of a contractor beyond the scope of the license; and, disregard and violation of state building laws. The Board revoked the license of Terra Landscape & Concrete Construction.

The Board revoked the license of **Sunset Construction Company dba Premier Construction**, license number 44414 (Residential and Small Commercial) based out of Las Vegas NV, under the provision of NRS 624.3018(2), which provides that the board may appropriately discipline any license with common officers to a disciplined license. The license of Primack Homes was revoked on 4/24/2001.
